(2 strands)

**DMC**

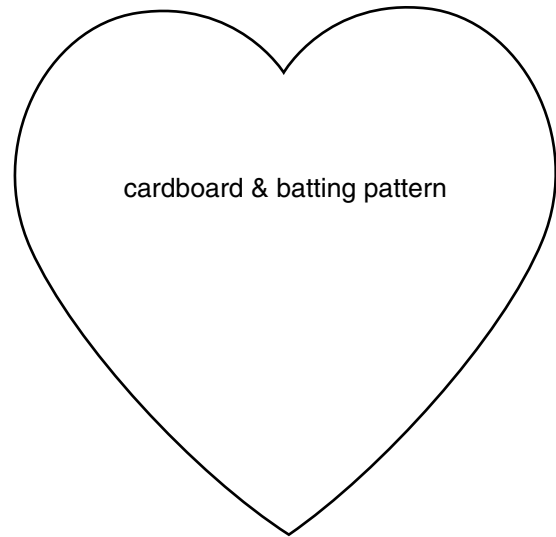
- ⊕ 956 Pink
- ♥ 321 Red
- ⊙ 208 Purple

**Back Stitch**

(1 strand)

**DMC**

- 844 Charcoal



**Project Supplies Needed**

- FolkArt® Extreme Glitter™ #2792 Red 2oz.
- FolkArt® #901 Wicker White 2oz.
- FolkArt® #437 Lipstick Red 2oz.
- Mod Podge® Gloss #CS11205 4oz.
- 6 in. x 6 in. x 3 in. heart shaped paper maché box
- 5 in. x 5 in. piece of purple felt
- 4 in. x 4 in. piece of posterboard
- 3 in. x 5 in. piece of quilt batting
- masking tape
- clear drying tacky glue
- 1 in. flat paint brush
- pinking shears

Design is approx. 2.71in x 2.71in. (6,88cm x 6,88cm)  
 Design is stitched on 14 ct. white Aida.  
 1 skein needed for each color.

**Directions**

1. Paint the bottom of the box with Lipstick Red, several coats may be needed. Allow to dry between coats.
2. Paint the top of the box with Wicker White, several coats may be needed. Allow to dry between coats.
3. Apply Red Extreme Glitter to the bottom of the box, several coats may be needed. Allow to dry between coats.
4. Apply Mod Podge Gloss to the entire box, several coats may be needed. Allow to dry between coats.
5. Use heart outline as a pattern to cut out a small piece of posterboard and quilt batting.
6. Place batting on top of cardboard then the cross-stitch on top of the batting, pull sides to the back of the cardboard and secure with masking tape.
7. Apply a small amount of glue to the back of the cross-stitch. Attach felt to the back, allow to dry.
8. Cut felt approx. 1/4 in. around heart using pinking shears.
9. Attach completed heart to top of the box with a small amount of the glue. Allow to dry.
10. Fill with candy or treat of your choice.
